

## RE: Geography GCSE field work trip – Wednesday 15th October 2025 LCO classes 11G1A and 11G2B

Dear Parents and Carers of Year 11 Geographers,

We are writing with details of the upcoming Geography GCSE field work trip. As part of the geography GCSE course, it is a compulsory element for AQA specification 8035: Paper 3 – Geographical Applications, to complete two geographical enquiries, each of which must include the use of primary data, collected as part of a fieldwork exercise.

The two enquiries must be carried out in contrasting environments and show an understanding of both physical and human geography. In at least one of the enquiries, students are expected to show an understanding of the interaction between physical and human geography. They will be expected to understand the following aspects of the process of geographical enquiry:

Suitable question for geographical enquiry

Selecting, measuring and recording data appropriate to the chosen enquiries

Selecting appropriate ways of processing and presenting fieldwork data

Describing, analysing and explaining fieldwork data

Reaching conclusions

Evaluation of geographical enquiry.

To minimise disruption to the students' other subjects, we undertake both geographical enquiries in one day. We aim to complete this in Term 1, while the weather is still likely to be clement. Students will be mostly with members of their own class, as well as some students from other geography classes.

<u>Date:</u> Wednesday 15<sup>th</sup> October 2025

Where to meet: Eastbourne station (inside)

When to meet: 09.15am – please ensure students are not late as this will impact the

field studies that we have planned.

**Lunch:** Students will have approximately 45 minutes to either eat a packed lunch

or purchase lunch in the town centre. If purchasing food, students will need to carry their own money. Students will be directed where they can go, and staff will remain in Eastbourne station throughout. Students will be in unsupervised groups for lunch but will be given the school mobile number. Parental consent can be indicated on the Google Form, link below. If students are entitled to a free school meal, this can also be indicated on the Google Form and will be brought by staff from school.

When to leave: 14:00 – 14:30pm – Eastbourne station (inside)

What to wear: Good shoes for walking/ appropriate, comfortable clothing for completing

field work/ outerwear to account for the weather forecast. If it is sunny, students should apply their own sun cream and bring a hat. If it rains, students should have a waterproof coat. A re-useable water bottle is also needed. Toilet facilities are available along the seafront. Please check the

weather forecast for the day.

Students will conduct two sets of field work investigations:

- 1) On the Beach: Beach profiles, width measurements, field observations on two beach locations close to Eastbourne pier.
- 2) In the Town Centre: Environmental quality surveys, land use transects and field observations in two town centre locations.

If your child is making their own way to and/or from Eastbourne Station parental consent is required on the Google Form. If there are any difficulties in getting to or from Eastbourne Station, please email <a href="mailto:bmarshall@willingdonschool.org.uk">bmarshall@willingdonschool.org.uk</a>.

## Fieldwork Permission Google Form
