# What qualifications do governors need?

There are no formal qualifications. Schools need volunteers with experience of life. The one essential requirement is an interest in, and commitment to, the education of children. Governors are ordinary people, drawn from many areas of society. They need to be able to devote time to getting to know the school well and be available to support and challenge it.

A governor must be a good listener, and someone who is able to read and take in information easily. A governor must be able to:

- raise questions and take part in discussion and decision-making
- be discreet, open minded and fair
- be a source of ideas and a good communicator
- be enthusiastic about the work of the school
- be prepared to work as part of a team.

Whilst schools are keen to welcome applications from all areas of society, there are certain criteria that have to be met before your application can be accepted. Please see the below requirements and complete Appendix 1B, 1C, 1D.

### How long do governors serve?

The usual term of office is four years. However, governors are volunteers who can leave at any time and can similarly be re-appointed or re-elected.

At Willingdon Community School we normally hold 5 Full Governing Body (FGB) meetings per year. You will also be required to serve on one of the working groups – a further 3-6 meetings a year. Each FGB meeting is held at 4.30pm on a Thursday and is a maximum of 3 hours per meeting. Each working group is held on a Wednesday from 3.45pm till 5.30pm.

### What kinds of help and support are available?

A great deal of professional advice and support is available to help governors with their duties and responsibilities, along with a full induction and training programme which is run by the Local Authority.
